# Terms of Use

## Welcome!

This document describes the terms and conditions that govern your use of the SECO-Institute website(s) ([seco-institute.org](http://seco-institute.org)) including subscriptions to SECO-Institute publications such as Daily Dashboard, web conferences, and the like (collectively the "Site").
